Classification of Adult Foster Homes

Classification	Qualifications of provider	Type of care provided
Class I	Less than two years experience providing direct care. Completion of basic training course.	Residents may need assistance in up to four activities of daily living (ADLs)
Class II	Two or more years experience providing direct care. Completion of basic training course.	Residents may need assistance in all ADLs, but are dependant in no more than three.
Class III	Health care professionals or others with at least three years experience providing care to people who are dependant. Completion of basic training course.	Residents may be dependant in four or more ADLs. The home may have only one resident at a time who is totally dependant.

DHS may allow, by written exception, a person to live in any classification of a home. The provider must be able to meet your needs, the needs of the other residents, and all health and safety standards.
